 - o Business picked up in August.
 - o Sent an Eblast to the members announcing the annual meeting and the agenda as well as one announcing the 'test' Caddyshack Classic matches. Added it to the News and banner on the WEB site.
 - o The Steel Plate matches added several new classes. IT wrote a matrix listing all of

- the classes and which matches allow which classes. Added it to the WEB site.
- Other than that just the normal maintenance, a few other minor WEB changes and communicating with a few members regarding questions.
- O Attacks on the WEB site have increased slightly (1,000 1,500 per week) but nowhere near past peak levels. If they increase much more IT may have to request a machine gun and ammo.
- o Patrick purchase camera equipment related to the CLUB security (\$160)
- Range and Grounds Report: Hon. Dan Ditullio read his R&G report
 - o Benchrest Range Cleanup Picked up steel cases in area
 - o Multipurpose Range cleanup painted steel cleaned up steel cases
 - Raked out pits
 - o Pistol Rnage Put gravel in pits one and two
 - Applied weed killers
 - o Installed new steel target at 22 range
 - o Trimmed right hand berm on 22 range

Membership Business:

- Members shooting club target stands with shotguns Range Rules infractions
 - Members in questions attended the meeting to voice their defense or reason for infactions
 - Kenneth Nagel and Rick Nagel
 - o Both father and son testified to causing the damage and range violations
 - Board of Directors issued the father and son to attend New Member Orientation and complete a Work Day.
 - o Both memberships will be suspended until they have completed the judgement set forth by the BOD
- Jeremy Trester did not complete the allotted time (exp. 11-2022) to finalize new membership
 - o Jeremy attended the 11-6-2021 New Member Orientation
 - o Jeremy came to the BOD meeting to explain his absenteeism
 - 1. Early 2022 Jeremy had health issues, hospital stays and loss of work days with far surpassed finalizing his club membership
 - 2. He also completed his work days
 - 3. He asked the BOD to consider his health situation scare and to be fexible, be would be glad to be a member of MRPC
 - o BOD issued Jeremy to complete another New Member Orientation to settle the case
- What to do when something is broken, damaged or smelly
 - o Answer: Call the President, Board of Directors, Mike Osley or Match Directors
- Match Director Reporting Policy Committee: Why is there all this discussion about "defending" the policy
 - The BOD established that committee, chaired by the VP (Scott Galloway), to address 3-4 Match Directors not fulfilling their match reports duties and the amount of revenue they are giving to the club.
 - o President received emails to ask the BOD on a consensus on why they took the vote as they did, on that policy
 - o President is asking "why" do we need to defend the vote that we took

- 1. The emails came from Board Members
- o Treasurer, John Herdering, stated the policy was:
 - 1. Increase in dues
 - 2. Club members no longer pay match fees, other than sanction dues
 - 3. Non-members are paying usage fee for coming to our club and damaging club property
- o Board Member questioned,
 - 1. "I don't understand the decision. I don't understand how we went from changing how the matches are run or how the matches are paid or actually how we went from reporting to not only now the club is subsidizing membership for."
 - 2. "To me, maybe it's more the optics of we're basically coupling 2 things that almost looks like we're using raising the dues in order to. To give a benefit to a small portion of the club that's using the club in a different way, and if you look at it from all the people. Who don't shoot matches match. It matches. You're getting my way of coming out here and shooting."
 - 3. If you're not somebody who shoots and matches, basically the way this is to me, the way I would interpret it, if I was a standard member that does not shoot matches, is that I still there's certain you know these matches now that a lot a very small subset of our club now gets to shoot for free without paying for it.
 - 4. "Why weren't the match directors, other than those on the committee, involved in the decision? Without their buy in this plan will likely fail."
- President directed VP-IT/Inv to write up announcement of BOD's proposal to increase the annual dues and match fees relating to members/non-members
- We're announcing to members correct prior to the annual meeting that there is they do increase of \$20, which based on increased costs, increased capital needs, increased cost, insurance increase. Membership on management fees is necessary to continue to operate the club, as an added benefit of your membership, you as a Member will no longer be charged match fees outside of sanctioning fees beginning January 1st.

New Business:

- Member, Angelika Farina
 - Civil Air Patrol
 - o Air Force program with youths, 12-18 years old
 - Looking for a place in hosting the cadets here. Requesting the club if they would consider having the cadets use the club.
 - A couple times a year on a Saturday or Sunday to offer the cadets marksmanship where it would be 1/2 a day classroom time, using the clubhouse to teach them marksmanship safety 1st and showing the position and the fundamentals of the prone position only is what we'd be doing and then shooting 22 long rifles.
 - The Board gave Angelika several locations and organizations to pursue and help in getting contact with them

- President, John Smith recommended Angelika to write up a proposal and give to the BOD
- Member, John Grote
 - Suggested to building a small house on the plot of land in front of our club, section of farmland we rent. The concept of Risk Mitigation for the club
 - o Have a club employee stay there 24/7, as long as he/she works for the club
 - o The person that maintains the club lives in the house and so on.
 - o The BOD listened to Mr. Grote's suggestions, with no decision in the matter
- Member, Mark Dorger
 - Requested on cleaning up the creek of the high vegetation for an upcoming rifle match
 - o BOD agreed to have the issue taken care of in a timely manner
- New Signs for the Multi-purpose range
 - o VP-Rifle, Ross Bowman to be in charge of the committee

Old Business:

- o Handrail on the pistol pit hill
 - Handrail to the cowboy Pit Committee reports that no further progress has been made. The project has not died.
 - Just has been out prioritized
- Porta Poty
 - The Porta Potty Research Committee report is that both earlier in the year and just this last week, President has reached out for bids on Porta Potties because the President is tired of contacting Rumpke about their poor service.
 - President, "If anybody we change to, it's going to double the cost of the Porta Potties. You you cannot touch from peace price."
 - Last Spring, our President talked to the Rumpke rep and condensed the two Rumke accounts into one, for a weekly service
 - President was told that we have biweekly service or every other week service.
 - Mike Osley checks the Porta Potty to see if Rumke missed a pick-up, if so our President calls them and they come with apologies
 - We pay Rumpke \$1,100 a month and changing to another service provider will double that amount
- o Mike Osley new 401K salary adjustment
 - We would, as a club have. To make a 2%. Non elective contribution to mikes account every year.
 - Which would be 2% of his salary.
 - In lieu of Christmas bonuses or any further increases to make sure he maintains his tax level that he wants to.
 - Treasurer made a motion that that we approve setting up a simple plan for for Mike and and it will cost the club \$700.00 a year approximately is 2% of his total pay being non electric.
 - BOD approved the motion

- Four Board seats are up for election
 - VP, VP-IT/Inv, VP-Pistol and R&G positions are up for election
 - Kevin Sanders, Doug Hoff are considering in running and Mike Keder is considering re-running for the Board

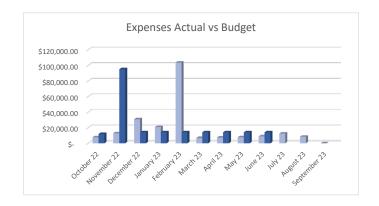

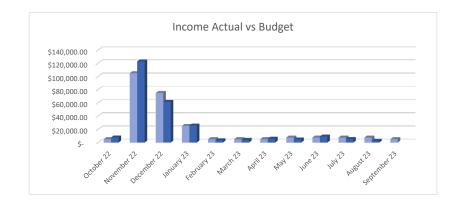

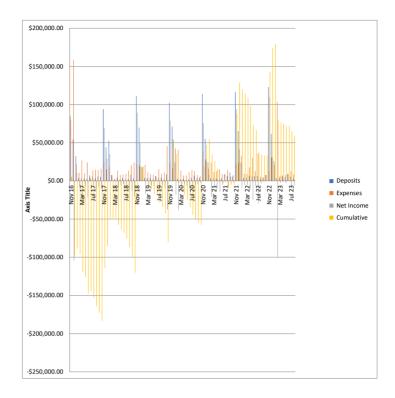
